## ARTICLE IV <br> MEMBERSHIP

1. To amend Article IV, Section 2 by striking out the comma, " per member" after "Annual dues" and the comma after "members".
2. To amend Article IV, Section 7 by striking out "and attendees of NSCNA meetings" and inserting "agree to abide by the bylaws of NSCNA and" after "Members"
3. To amend Article IV by adding new Section: "8. Membership lists or rosters shall only be used for official activities of the association and shall not be shared with any other group."

## ARTICLE V OFFICERS

4. Amend Article V, Section 1 by inserting a comma and "of which he shall not be a member" after "Committee" before the period.

There shall be four Officers of the Association. These shall be a President, Vice President, Secretary, and a Treasurer. The duties of the officers, in addition to those prescribed by parliamentary authority, shall include the following provisions:

## ARTICLE VI

## BOARD OF DIRECTORS

The management of the Association is vested in the Board of Directors. The Board of Directors shall be the principal representative, governing, and policy-recommending body of NSCNA. Actions of the Board of Directors shall be governed by the will of the membership as expressed at general and special membership meetings unless such action is prohibited by State or Federal Law, the NSCNA Articles of Incorporation or Bylaws.
5. Amend Article VI, Section 2 by inserting a semi-colon and "such notice shall not be required if all directors execute a waiver" after "five (5) days notice of any meeting" before the period.

7. Amend Article VII, Section 7b by inserting a comma and "email" after "website and by mail".

## ARTICLE VIII <br> COMMITTEES

There shall be three (3) classes of committees within the Association: standing committees, special issues committees, and special committees.
8. Amend Article VII, Section 1b by striking out the last sentence "The Chairperson of this committee must be a member of the Board of Directors and liaison between the Association and the media."
9. Amend Article VIII, Section 3b by striking out "add their names to be included in the election" and inserting "be nominated to serve on the committee" after "current members may".

## ARTICLE IX NOMINATIONS AND ELECTIONS

10. Amend Article IX after"NOMINATIONS AND ELECTIONS" by striking out "as well as a paid member" after "to be a current member", and striking out "prior to" after "January 1", and inserting "of the year of" after "January 1".

Original text:
Elections for the four (4) Officers and seven (7) Directors of the Board of Directors shall be held at the annual January meeting of the general membership. Nominees for an Officer of Board of Director position shall be required to be a current member as well as a paid member of the Association for the year beginning January 1 prior to their election. The Treasurer shall confirm eligibility and payment of dues by all nominees.

Proposed Amendment:
Elections for the four (4) Officers and seven (7) Directors of the Board of Directors shall be held at the annual January meeting of the general membership. Nominees for an Officer of Board of Director position shall be required to be a current member as well as a paid member of the Association for the year beginning January 1 prior to of the year of their election.
